### 1. DATA OWNER\

### 2. OBJECT OF PROCESSING

Processing for purposes b, d, and e may be carried out on the basis of the legitimate interest of the Data Owner.

### 4. STORAGE PERIOD

The data will be kept for the time necessary to fulfil the above purposes and, in any case, for no longer than 10 years from the date of fulfilment of the above purposes.

### 5. DATA ACCESS AND COMMUNICATION

The data will be made accessible and/or communicated, where strictly necessary, to:
